### **General Policies:**

Please call our office at (602) 396-8321 to make sure we have openings in your timeframe.

Our Office Hours are Monday – Friday 9:00AM to 4:00PM. Our Office is closed Sundays and Saturdays. However, our instructors' work 7 days a week, so we can accommodate most appointment times within reason. Lessons can be scheduled 24 hours per day at www.legacydrivingacademy.com.

Payment in full is required in advance to secure your driving lesson reservation. Please note there are no refunds once payment has been received. (We have a no refund policy)

You will receive a calendar invite that outlines your scheduled lessons. Please review the information carefully and contact us immediately if you have any questions or require any changes. NOTE: If your calendar settings is not set to the correct time zone (Arizona) your lesson times may appear to be incorrect.

The Behind the Wheel packages will expire one year from the date of purchase.

Students must bring their valid AZ Driver's Permit to each lesson (or Drivers License or International License, if applicable).

All lessons must be scheduled within 30 days of payment (but they do not have to be completed within 30 days of payment).

Spouses, parents, friends, siblings and children are not allowed to accompany the student during lessons due to insurance purposes.

We do not guarantee students will pass their written or behind the wheel tests at the MVD.

Upon passing the Road Skills Evaluation under the Legacy Premier 10 hour program, the student's information will be entered directly into the MVD system with a status of Pass. The student will still need to go to the MVD or Third Party MVD location to obtain their Driver's License. The Road Test Waiver expires one year after completion date. If the student fails to obtain their Driver's License before it expires, the Behind the Wheel course needs to be retaken to re-evaluate the student's driving ability.

Due to unsafe road conditions during heavy rainstorms or dust storms, Legacy Driving Academy reserves the right to cancel driving lessons due to weather conditions. We will make every effort to reschedule you to the next available time that fits your schedule.

Because we want our cars to always be in optimal working order and safe for our students, lessons may have to be rescheduled due to unforeseeable car issues (even though we keep all cars on a strict maintenance schedule). Should this happen, we will make every effort to reschedule you to the next available time that fits your schedule.

#### **Cancellations and No Shows:**

We do not issue refunds or credits if you miss your scheduled lesson or do not show up, please give notice if changes must be made to your schedule 48 hours prior to the lesson. Availability may be limited when rescheduling on short notice. If 48 hours notice is not given on any scheduled appointments a \$75.00 rescheduling fee will be required. #### **Minor Release Consent**

I FULLY UNDERSTAND and will instruct the Minor that: (a) participation in these Activity(s) including learning to drive is VERY DANGEROUS and involves RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by the Minor's own actions, or inactions, the actions or inactions of others participating in the Activity(s), the rules of the Activity(s), the surface conditions of the roads which are traveled upon for purposes of learning to drive and/or THE NEGLIGENCE OF OTHER DRIVERS, OTHERS USING THE ROADS AT THE SAME TIME AND OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS NOT KNOWN TO ME or that are not readily foreseeable at this time; (d) THE SOCIAL AND ECONOMIC LOSSES and/or damages that could result from those Risk(s) COULD BE SEVERE AND COULD PERMANENTLY CHANGE THE MINOR'S FUTURE.

I consent to the Minor taking this driver instruction class and participating in all the Activity(s) involved in learning how to drive a vehicle.
